WHEREAS, \$50 is on the very low end of recommended and implemented fees for Short Term Rental permits; and

WHEREAS, City Council approved Resolution 2022-126: Adopting the Calendar Year 2023 City of Seward Fee Schedule during the December 12, 2022 Regular City Council meeting; and

WHEREAS, these fees will help defray the cost of the online registration tool, permit processing, and short-term rental tracking software.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SEWARD, ALASKA that:

Section 1. The Seward City Council hereby approves the 2023 Seward Fee Schedule as amended to include the \$50 Short Term Rental Permit Fee to the Community Development Fees as attached herein.

Section 2. This resolution shall take effect immediately upon its adoption.
