- *Customers may apply for a fire hydrant usage permit from May 1 to September 30 and shall use a hydrant designated by the water system operator. A hydrant valve must be used.
- (b) Only Public Work personnel, or fire department personnel in the case of a fire, shall use any fire hydrant without first applying to the city and agreeing to pay the appropriate charges and deposits. (Ord. 504, 1982; Ord. 95-06)

14.10.065 - Persons authorized to turn on or off water service.

Only the city shall turn on or off any water service or open or close any fire hydrant; except, that a licensed plumber may turn on a water service for testing his work and a person holding a fire hydrant usage permit under section 14.10.035 may use a fire hydrant in accordance with that permit.

CONDITIONS FOR ISSUING PERMIT

NOTE: A fire hydrant is an emergency water hydrant intended primarily for use by the Fire Department and the Public Works Department. This use permit is a privilege that may be revoked at any time that the Public Works Department or Fire Department determines continued use will interfere with Utility or Fire Department operations, or the permit holder violates any of the following conditions. Permits will not be issued during freezing weather.

- 1) No fire hydrant may be used without first paying the stated fees. Person(s) using a hydrant without a permit will be charged a weekly fee of \$324.84 and a penalty of \$1,082.77 per incident.
- 2) After payment of a fee, the fire hydrant will be turned on and off by the Water Department representatives.
- 3) No attachments will be left on a fire hydrant overnight or when not in use, except by written authorization noted above.
- 4) The City Public Works and/or Fire Departments representative may disconnect and remove any fittings attached to the hydrant at any time without notice or recourse by the permit holder. The City will not be held responsible for any damage to fittings.
- 5) The permit holder will protect the hydrant from damage, report any damage promptly, and reimburse the City the cost of repair of any damage caused by his/her use of this permit.
- 6) An approved back flow prevention device will be installed between the fire hydrant and a ship; and/or other point of delivery when in the opinion of the City representative; it is required to protect the City's system. A shut off valve, if required by the Water Department, will be installed.
- 7) The City will serve potable water at the hydrant, but cannot be responsible for water quality beyond the hydrant when it enters the permit holders fittings, hose, or vessel.

<u>RELEASE</u>: In exchange for this fire hydrant permit, I release the City of Seward, its agents, and employees from any and all liability arising from or connected with my use of this permit. I agree to defend and hold harmless the City and/or Fire Department for any personal injuries to myself or others and any property damage or other liability, which might arise from my use of the permit. I agree to attach only authorized fittings to the fire hydrant and to protect the hydrant from damage. Should the City or others remove my fittings, I will not hold the City responsible for the damage to my fittings. I shall reimburse the City for the cost to repair any damage to the fire hydrant, backflow preventer and meter.
